Highway 417 Nicholas Street Underpass Replacement (Site #3-224) (GWP 4048-11-00), Detail Design

THE STUDY

The Ministry of Transportation (MTO) completed the Detail Design and Class Environmental Assessment (EA) for the replacement of the Highway 417 Nicholas Street Underpass (Site #3-224) (GWP 4048-11-00), in the City of Ottawa.

The scope of work involves the following:

- · Full replacement of the existing bridge on a new alignment immediately west of the existing bridge;
- Re-alignment of the associated interchange ramps (specifically, ramps in the northwest and southwest quadrants) as required by the new bridge alignment;
- Short extension of the fourth Highway 417 through lanes in each direction, to just west of the Nicholas Street Underpass: and
- Construction of related works, including drainage, illumination, and roadside protection barriers.

The replacement of the underpass will require two single overnight full closures of Highway 417 for the erection of the new bridge girders over the highway and for the demolition of the existing structure. Each closure will occur over two separate weekends. Traffic will be



detoured during this time. Traffic management for construction staging is being coordinated with the City of Ottawa.

THE PROCESS

This study was carried out in accordance with the approved environmental planning process for Group 'B' projects under the MTO Class Environmental Assessment (Class EA) for Provincial Transportation Facilities (2000), with the opportunity for public input throughout the project.

The purpose of this notice is to inform the public that a Design and Construction Report (DCR) has been prepared and will be available for a 30-day public review period from April 17, 2018 to May 16, 2018. The DCR documents the Class EA process followed, a description of the Recommended Plan, potential environmental effects, and the final mitigation plan.
